- **DfE announcements**

- I am sure that you will have heard Gavin Williamson's [press briefing and announcements](#) yesterday and I think it is safe to assume that we are nowhere near the point of schools getting back to normal. Do have a look at the resources that have been made available via the new [Oak National Academy](#) which launches today. They are already quite active on Twitter and you may want to follow them [@OakNational](#). The Church of England Education Office has been asked to provide a weekly act of collective worship as part of these resources so do look out for that and the [BBC's home learning resources](#).
- I am sure that you will have heard about the IT equipment that the DfE is providing for disadvantaged pupils and I believe that local authorities are coordinating individual school needs so that nobody who is eligible misses out. If you would like us to make representation to either Dudley or Worcestershire LA on your behalf or if you are struggling to register your school needs, do let us know and we will see if we can help. Remember when you are in touch with the LA to include information on whether your school site is open and where hardware will need to be dropped off, if appropriate.

- **Relationships and Sex Education (RSE)**

- You will be relieved to hear that the implementation date for the new RSE requirements has been moved back to September 2021 to enable schools to carry out the required consultations and to prepare sufficiently.
- As you know, we had planned RSE training that many of you had booked to attend this coming Thursday 23rd and Friday 24th April but we had postponed it. The training has now been rescheduled for **Tuesday 22nd and Wednesday 23rd September 2020**. If you had originally booked a place for Thursday 23rd April this will be automatically transferred to Tuesday 22nd September; and if you had booked onto Friday 24th April your place will now be allocated to Wednesday 23rd September. Rob Stephens, our new Buildings Adviser, will be in touch shortly with those who have submitted bids to discuss how we intend to progress. Building projects may be highly problematic this year but we will do as much as we are able to.
- **Bereavement Support Material**
 - A sad reality of the new world in which we live is that many more children and young people are going to be dealing with bereavement and loss than in previous years. Schools are very skilled at helping their pupils in these circumstances but we may all feel more overwhelmed than normal in the current circumstances. The Church of England is in the process of putting together some support material which we will share with you soon.


Important Diocesan Education Team Update #8, Tue 21 April 2020
